

Town of Sumner Minutes

Tuesday, June 13, 2023

The regular meeting of the Town of Sumner Board was called to order on Tuesday, June 13, 2023 at 6:00 pm by Chairman Darrel Smith. Postings were verified.

Present: Chairman Darrel Smith, First Supervisor Tim Wilson, Second Supervisor Roger Johnson, Treasurer Shelley Christopherson, Clerk Emily Wilkinson.

Also present: Jon, Ingrid and Naomi Logterman, Emily Kaltenberg, Kevin Rongstad

Motion by Darrel and seconded by Tim to approve the minutes from the previous meeting. Motion carried.

Motion by Darrel and seconded by Tim to approve the Board of Review minutes with the correction as noted by Emily. Motion carried.

Shelley reported there was an unknown deposit for \$129.12. The Treasurer's report was approved with a motion by Roger and seconded by Tim. Motion carried.

Public Input- Jon and Ingrid Logterman are local beekeepers in the township and discussed how they are doing their best to minimize any problems with bees that some residents have complained about.

Roads Report-None

Website- designer is still working on site, no update.

A motion was made by Darrel and seconded by Roger to transfer \$200,000 from CCF Bank to Alliance Bank. Motion carried.

Banking/credit card- need to fill out credit card application. ARPA savings will be moved to Alliance Bank-Emily will inquire if we can put into a CD.

Shelley presented a revised draft of an employment contract for review.

A motion was made by Roger and seconded by Tim to approve liquor licenses for Osseo Rod & Gun, Grand Occasions, Osseo Merchants Baseball, Osseo Golf & Rec. A Class B Picnic License was approved for Osseo Lake Martha Days Horse Pull.

In order to sell the property/park on Golden Valley Road, we need to have a special meeting of the electors. The attorney is contacting the heirs to sign off.

More discussion was held on storage of bees in the township-need village powers to be able to create any kind of ordinance. The board will continue to research beekeeping and look into

what other municipalities have in place. The current area where bees are stored is zoned agricultural.

Bartenders licenses were reviewed and approved with 2 applications needing proof of the bartending course. Roger made the motion to approve with a second by Tim. Motion carried.

The assessor contract was approved with a motion by Darrel and seconded by Roger. Motion carried.

A fireworks permit was approved for Osseo Merchants on June 28 with a motion by Darrel and seconded by Tim. Motion carried.

A motion was made by Darrel and seconded by Roger to approve a fireworks permit for David Congos. Motion carried.

Insurance Agent Emily Kaltenberg presented information regarding our current policies and making updates to our inventory, driver list and underinsured/uninsured coverage.

Meeting to discuss village powers-no discussion.

Emily would like to work on long range planning for the township for buildings and equipment. This will be a work in progress.

Bills were approved and paid with a motion by Roger and seconded by Tim. Motion carried.
